## Art.1 Introductory provisions

- 1.1 The scholarship is granted to students in bachelor and master study programmes for the duration of an academic year with the exception of the months of July, August and September. The scholarship is granted to students in doctoral study programmes for the duration of an academic year with the exception of the month of July.
- 1.2 Students coming to CTU as part of short-term or long-term exchange programmes are not entitled to an accommodation scholarship.

## Art. 2 Criteria for granting an accommodation scholarship

To an accommodation scholarship are entitled students who:

- 1.3 study in a bachelor, master or doctoral study programme in the full-time form of study in an accredited study programme in the Czech language,
- 1.4 study in the first study programme or in a study programme which is a follow-up study programme to the first study programme or who have transferred to another programme and had their previous studies recognized. In case of two study programmes studied in parallel, the student is entitled to an accommodation scholarship only in one programme, namely in the programme in which they have enrolled first.

The so-called holiday studies, i.e. studies in which the applicant enrolled and which they completed between 1 May and 30 October of the same calendar year, are not considered a first study programme.

- 1.5 have not exceeded the standard period of study in any of the study programmes studied in parallel,
- 1.6 their permanent address is not in the same district as the place of their studies,
- 1.7 their permanent address is not in the capital city of Prague if the place of their studies is in the territory of the capital city of Prague,
- 1.8 are students of CTU and on the day their eligibility for an accommodation scholarship is assessed they are on a long-term (longer than 30 days) study stay abroad, such as the Erasmus, Socrates, Barrande Fellowship Programme etc. In this case also students pursuant to Para 2.1 whose permanent address is in the same district as their place of studies and students whose permanent address is in the capital city of Prague and the place of their studies is also in the territory of the capital city of Prague are eligible.
