Procedure for submitting the Thesis Deferral Request:

- Deadline for submitting the student's request, including an attached consent of the Thesis supervisor, to the head of department/institute: no later than 30 days before the deadline for Thesis submission.
- The request, including consent of the head of department where the Thesis is to be defended, is then submitted to the Dean for decision (see Art. 4.1 of the Thesis Methodological Guideline).
- After the Dean's decision, the request is forwarded to the study department no later than a week before the Thesis defence date.
- The maximum length of Thesis publication deferral is five years (Sec. 47b of Act No. 111/1998 Coll.).
- If the Dean agrees with the deferral:
 - The study department officer sets the length of the publication deferral in accordance with the Dean's decision (see Art. 4.1 of the Thesis Methodological Guideline) and uploads the Dean's decision to the IS KOS.
 - o The IS KOS sends a notification email to the student.
- If the Dean rejects the deferral:
 - The study department officer notifies the student, the Thesis supervisor and the head of department/institute by email and adds the request to the student's file.
