

## Scholarship for excellent study results

(does not apply to LLP)

In the academic year 2025/2026, you do not have to submit any application form in order to be awarded the scholarship for excellent study results in the academic year 2024/2025. The scholarship will be automatically awarded to everybody who fulfils the prescribed conditions.

## Conditions for awarding the scholarship:

In the academic year 2024/2025, your results at FBME CTU are as follows:

- 1) you gained at least 60 credits from the completed subjects
- 2) your **weighted average** from the completed subjects was less or equal to **1,50** (it is calculated according to the Study and examination rules of the CTU, rounded up to 2 decimal places for the subjects completed in the academic year as a whole it is not the average from two semesters)
- 3) the number of completed, graded subjects was 8 and more
- 4) you were a **FBME CTU** student
- 5) you studied in the **standard** length of study

Recognised subjects are not included!!

## and in the academic year 2025/2026:

- 1) you are still a **FBME CTU student** i.e. your studies continue in the same bachelor or follow up master study program as in the academic year 2024/2025 or in the academic year 2024/2025 you graduated from the bachelor study program and in the year 2025/2026 you are in the 1 st year of follow up master study program. In other cases, the scholarship is not granted. These are: studies of the graduate from the follow up master study program in another bachelor or follow up master study program, studies of the graduate from the bachelor studies in another bachelor studies, studies in another bachelor or follow up master studies after unsuccessful completion of the bachelor or follow up master studies
- 2) you study in the **standard length** or in the standard length prolonged by 1 year at maximum

## You will be awarded the scholarship only if you fulfil all the above listed conditions!

We will process and assess the scholarships on **October 5, 2025** (the final date according to the Directive of the Dean concerning bachelor and follow-up master study programs at CTU FBME) according to the study results recorded in KOS.

We will inform you by email whether you are entitled to the scholarship and you will be invited to **pick up the Decision in person** at the study department (in the building called "KOKOS" within the office hours) – you will confirm its acceptance **by signature**.

The payment of the scholarship will be one-off (by wire transfer to the account, which you have in KOS on October 5, 2025) and after the Decision becomes final and conclusive. (The decision will become final and conclusive 15 days after its acceptance or on the day on which you waive your right to appeal in writing - you can do this by one more signature right after the acceptance of the Decision at the study department.)
